To enroll in the plan, complete a GRS **RRSP member application form** available on the website at www.grsaccess.com and send it to GRS. You may also request an enrolment form from GRS' Access Line at 1-800-724-3402, or Laura Zacharias at Mennonite Church Canada. If you are not currently participating in the pension plan, you can contact Laura for the GRS retirement planning guide and CD-ROM.

Contributions to the Group RRSP can be made either by Pre-Authorized Contributions (from your bank account), or by lump sum (cheque) directly to GRS.
